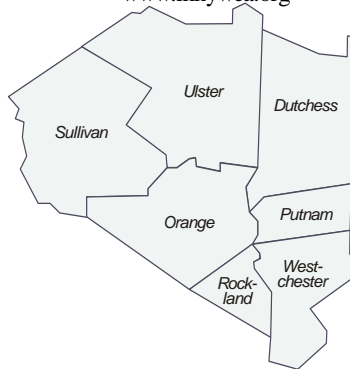

## **Directions to Krucker's Picnic Grove and Catering**

### **From Albany and points North:**

Take the N.Y.S. Thruway (Route 87) South to Exit 16, Harriman. Go through the tollbooth and bear right onto Route 6 off ramp. Turn left at off ramp traffic light and follow to second traffic light. Turn left onto Route 6 East. Follow 5 miles to traffic circle. Take Palisades Parkway South to Exit 14. Turn right off exit onto Willow Grove Rd. Follow 1/2 mile to Krucker's Street Sign. Turn left at sign onto Call Hollow Rd. Krucker's Catering & Picnic Grove is 2 miles on the right.

### **From New York City & Points South:**

Take the Palisades Parkway North via the upper level of the George Washington Bridge. Follow the Palisades Parkway North 25 miles to Exit 14. Turn left off the exit onto Willow Grove Rd. Follow 1/2 mile to Krucker's Street Sign. Turn left at sign onto Call Hollow Rd. Krucker's Catering & Picnic Grove is 2 miles on the right.

### **Garden State Parkway & Points South, New Jersey:**

Take the Garden State Parkway North to the end. Stay right onto the N.Y.S. Thruway (Route 87) South. Follow Thruway South to Exit 13N, Palisades Parkway North. Follow the Palisades Parkway North to Exit 14. Turn left off the exit onto Willow Grove Rd. Follow 1/2 mile to Krucker's Street Sign. Turn left at sign onto Call Hollow Rd. Krucker's Catering & Picnic Grove is 2 miles on the right.

### **Route 287 & Points South, New Jersey:**

Take Route 287 North to N.Y.S. Thruway (Route 87) North. Stay in right lane. Follow 2 miles to Exit 15A, Route 59, Suffern. (\*If you miss this exit, you will be stuck on Route 87 for 20 miles.)

Turn right onto Route 59. Follow 1 mile to traffic light. Turn left at traffic light onto Route 202 North. Follow Route 202 seven miles to 2nd traffic light at Route 306 intersection. Turn left at traffic light. Follow to stop sign. Turn right and follow 1/4 mile until the road forks. Bear left at the fork onto Call Hollow Rd. (a.k.a. Route 75). Krucker's Catering & Picnic Grove is 1 mile on the left.

### **Route 17 & Points South:**

Follow Route 17 North until it intersects with Route 87 North (N.Y.S. Thruway). Follow Route 87 North to Exit 15A(Suffern). (\*If you miss this exit, you will be stuck on Route 87 for 20 miles.) Turn right from off ramp onto Route 59. Follow 1 mile to traffic light. Turn left onto Route 202 East. Follow Route 202 seven miles to traffic light at Route 306 intersection. Turn left at traffic light and follow to stop sign. Turn right and follow 1/4 mile until the road forks. Bear left at the fork onto Call Hollow Rd. (a.k.a. Route 75). Krucker's Catering & Picnic Grove is 1 mile on the left.

### **Palisades Parkway & Points South:**

Take the Palisades Interstate Parkway. North to Exit 14. Turn left off exit, onto Willow Grove Rd. Follow Willow Grove Rd. for 1/4 mile; turn left onto Call Hollow Rd. Krucker's Catering & Picnic Grove is about 2 miles on the right side.

### **Palisades Parkway & Points North:**

Take the Palisades Interstate Parkway. South to Exit 14. Turn right off exit, onto Willow Grove Rd. Follow Willow Grove Rd. for 1/4 mile; turn left onto Call Hollow Rd. (a.k.a. R.C. Highway #75). Krucker's Catering & Picnic Grove is about 2 miles on the right side.
